



**Stokes Landing Sport Horses
Breeding Contract 2008
Speedking, Live coverage only**

I, _____, (hereafter, referred to as Mare Owner) agree to breed my mare _____, to the Morgan Stallion Speedking for the season of 2008. Contract shall be for live coverage, with a two-year Live Foal guarantee subject to provisions below. Irina Walker, of Stokes Landing Sport Horses (hereafter, referred to as Stokes Landing), agrees to provide Stallion service from the above stallion to the named mare of Mare Owner above. Both Irina Walker and Mare Owner mutually agree to the following conditions:

1. Mare Owner agrees to pay the stud fee as listed (please initial): _____ Speedking stud fee \$850.00
2. Stud fee is checked above. Of this amount, \$300 is a nonrefundable booking fee, which is due with the contract.
3. Mare Owner hereby verifies that mare is in good health and also has a good history of reproductive health. Mare Owner agrees to provide a veterinary certificate that a current uterine culture and cytology shows that the mare is free from infection and is in good sound breeding condition prior to breeding. This is also required of maiden mares. (You may have the culture done on the same heat cycle your mare is bred in).
4. Live foal Guarantee is subject to Mare Owner reasonably attempting to breed the mare, and limited to two years (two breeding seasons) if there are breeding difficulties. Mare Owner must have mare ultra sounded for pregnancy and twins by a licensed veterinarian, between days 15 and 20 from possible conception. Mare Owner must also have the mare ultra sounded and checked for pregnancy for a second time approximately 45 days after breeding. If Mare Owner does not do these ultrasounds, the Live Foal Guarantee provision is null and void. If the mare fails to conceive or produce a live foal that stands and nurses, then the mare may be re-bred to Speedking, provided it is within the two years of the contract. The Mare Owner must provide written verification of a statement of details by a licensed veterinarian's opinion, including feeding, worming, vaccinations, and care appropriate to a mare in foal.
5. Mare Owner agrees to ask their veterinarian regarding vaccinating the mare for Rhino-Pneumonitis between the 5th and 9th month of pregnancy, as it may be prudent to do so if the mare is exposed to outside horses.
6. In addition, this contract cannot be assigned or sold without Stokes Landing's consent. In the event of the mare's death or being unfit to breed, this contract is null and void, and can only be transferred to another mare with Stokes Landing's consent. In the event of the death of the stallion, a full refund will be available. Stokes Landing and Irina Walker shall not be liable or responsible for any disease, accident or injury to the mare to be bred, nor shall the owner of the mare be responsible for any disease, accident or injury to the named stallion. Speedking is a proven foundation Morgan stallion, and Irina Walker agrees to provide the breeding certificate. It is the Mare Owner's responsibility to verify the registration requirements for the foal, which also includes DNA typing for mare and foal.
